DTI E-Supply Chain Solutions

1. Requisition Manager

The Web-enabled Requisition Manager allows your organization to generate purchase requisitions from any location worldwide. The Shared Specifications Library provides an environment to create, store, and re-use specifications. The Requisition Manager provides many user friendly features such as an easy to use Shopping Cart interface, Global Products and Services search engine, automatic budget, stock availability and supply agreement verification, and integration with the Business Rules and Workflow Manager module for simplified document routing and approval management.

2. Procurement Manager

The Procurement Manager module supports both direct and competitive bidding procurement practices for public and private organizations. The system supports all major commodity code formats (UNCCS, UN/SPSC, SIC, GSA, etc.), automatic supplier short-listing, electronic bid document generation, distribution, and reception, and the ability to interact with customers and suppliers in "E-Mall" and "Exchange" trading environments. The software system utilizes a patented competitive bid evaluation facility, which evaluates supplier responses to all types of procurement actions. The Procurement Manager module also supports a database of local and international suppliers and manages their performance and ability to meet contractual obligations.

3. Contracts Manager

The Contracts Manager provides the ability to comprehensively manage services, supply, or works contracts. This module supports single and multiple supplier contracts, multiple vendor/item schedules, multiple price structures, "mini-bids" for multi-vendor contracts, and terms of reference.

4. Shipping & Distribution Manager

The Shipping & Distribution Manager module tracks the transit of any item from the point of origin to its final destination in an on-line environment. The module provides an exclusive international price and commodity code database for price verification on imported goods and duty assessment/customs clearance and supports multiple receiving reports,

centralized receiving at a distribution center, and links to the Inventory Manager module. Items that are received into inventory are automatically assigned an optimal put-away location by the system, while items to be tracked as inventory or assets are automatically identified with system-generated barcodes.

5. Inventory/Stores Manager

The Inventory/Stores Manager module provides all of the tools necessary to effectively monitor, track, and manage every inventory item within your organization. Real-time demand forecasting and stock replenishment reduces holding costs and ensures on-hand availability of critical items when needed. Every item is tracked from the moment it is purchased until its disposal, enabling your organization to effectively manage the procurement, storage, and distribution of inventory items. The Inventory/Stores Manager supports integration with all types of bar-code scanners for increased efficiency in inventory verification and tracking.

6. Assets Manager

The Assets Manager Module tracks the fixed, moveable, fleet, and facility assets of an organization. The module provides on-line and real-time information for financial accounting, control and auditing. This module is linked to the Inventory and Stores modules, allowing for internal leasing and the movement of equipment from asset to inventory during work force reduction and vice-versa.

7. Fleet Manager

The Motor Vehicle Fleet Manager module monitors and maintains the vehicles in an organization's motor pool. Each vehicle is tracked from purchase to disposal or auction. Equipment histories and maintenance logs are kept for each vehicle to ensure proper preventative maintenance and repairs. Preventative maintenance is interfaced with the standard assets/facilities maintenance to automatically execute scheduled work orders.

8. Facilities Maintenance Manager

The Facilities Maintenance Manager module tracks a master list of fixed assets. Your organization will have the ability to schedule building inspections, perform routine maintenance, and handle emergency situations through a link to the Procurement Manager module for the rapid sourcing of

repair work. The system automatically tracks data such as landscaping, utilities, structure, replacement and servicing schedules for lighting, air conditioning equipment, elevators, labor, etc.

9. Capital Equipment Maintenance Manager

The Maintenance Manager module tracks the total maintenance of all equipment and capital assets. This module provides the ability to completely monitor and maintain all parts and subassemblies of an asset.

1. Requisition Manager Business Edition

The Requisition Manager Business Edition is a version of our standard Requisition Manager module, which has been streamlined to meet the specific requirements of private organizations. Remote Electronic Requisitioning provides the ability to submit, process, and approve purchase requisitions for goods and services electronically on-line, and Shopping Cart Requisition Interface.

2. Procurement Manager Business Edition

The Procurement Manager Business Edition supports all standard and international commodity codes and classifications and the ability to electronically generate, send, and receive all types of bid documents including requests for information, quotations, proposals, and bid amendments. All relevant purchase requisition information is captured and integrated with standard bidding solicitation format(s) to form an RFI, RFQ, or RFP. These documents can then be forwarded electronically to short-listed suppliers for competitive bidding. The Procurement Manager Business Edition also supports Direct Purchase Orders for approved requisitions.

3. Contracts Manager Business Edition

The Contracts Manager Business Edition provides the ability to easily manage blanket or single item term contracts with single or multiple suppliers for items commonly used by most departments and the consolidation of requisitions from multiple departments for volume discount contracts. Management of completion and payment milestones for construction and works contracts ensures that payment is made for only those milestones which are certified as completed to contract specifications as well as Electronic Contracts and Signatures.

4. E-Marketplace Portal/Web Mall

Decision Technologies International, Inc. provides customized B2B web based "Exchange" environment for our clients who wish to interact with their suppliers in a central "storefront" on the Internet. Suppliers with valid term contracts can list the goods and services which they provide on the Exchange, allowing authorized users to view product descriptions and

specifications, video, pictures, price catalogues, delivery information, company data, etc. Approved requisitions may automatically be submitted to a vendor on the Exchange for processing with links to all contractual terms and conditions such as payments, delivery status, etc. Data integrity and system security is ensured through the use of sophisticated digital signatures and password encryption. Each E-Marketplace Portal is designed to the unique needs of the client and may be expanded as your B2B relationships

DTI Financials

1. Budgeting

The DTI Financials Budgeting Module maintains budget funds and current funding availability in real time with support for various types of funds management including General Funds, Special Funds, Enterprise, and Capital Projects funds. Cost center accounting supports real-time analysis of overhead costs and cost assignment to organizational sub-divisions. Activity-based accounting supports the allocation of costs to items based on cost sources with budget summary reports available for management analysis. The Budget Module is fully integrated with General Ledger, Procurement, and Requisition Modules.

2. Budget Sensitivity Analysis

The DTI Financials Budgeting module provides the forecasting and sensitivity analysis tools to assist in proactive management of the fiscal planning process. Real-time "What-If?" analysis may be performed on each line item of the revenue / expenditure component of budget proposals to determine their sensitivity. The module supports user-definable input parameters for custom analysis and "What-If" scenarios for revenue and expenditure parameters.

3. General Ledger

The General Ledger is essential both to the financial accounting system and to strategic decision-making. Through active integration with business processes in the purchasing and logistics software, the G/L serves as a general pool of financial data for financial reporting, as well as for other accounting areas. The General Ledger module features unlimited user-definable journals for accounts payable, accounts receivable, payroll, purchasing, revenues, cash disbursement, cash receipts, general and budget journal categories. All ledgers are automatically updated simultaneously from one series of entries. The module provides the ability to perform full general ledger management including funding sources and departments, automatic and manual execution of general ledger transactions, and transaction archiving support.

4. Accounts Payable

The Accounts Payable module of DTI Financials enables the automatic monitoring execution of various invoice payments. This module supports proforma invoices and the ability to pre-pay orders based on a proforma invoice, automatic registration of standard invoices, automatic links to associated purchase orders, packing lists, and receiving reports. On-Line payment of invoices may be made from any location with access to the system.

The system automatically matches qualified applicants to positions within the organization, prepare a job description and chart a career development plan for each new hire. The system is equipped with a library of behavioral traits and technical skills for every job description.

2. Attendance Monitoring / Time Management

Once a position is filled with a qualified applicant, the next step to ensuring maximum efficiency is to track the time the employee spends on the job. This is accomplished through the use of a time card / badge reader system that is integrated with the DTI Payroll Management software.

This tool allows managers to establish performance activities and goals for an employee then perform a periodic rating and scoring of the employees accomplishments for each activity with support or justification for each score.
